Call for Applications for the Position of Research Assistant

The Centre for Aviation and Space Laws (CASL) at The West Bengal National University of Juridical Sciences (NUJS), Kolkata, is inviting applications for a single post of research assistant for an upcoming project on airport governance in India in the wake of international obligations. The project will be carried out in collaboration with the Centre for Research in Air and Space Law at The Maharashtra National Law University, Mumbai. The duties of the research assistant will include among other things fieldwork to be carried out at several Indian airports, doctrinal and empirical research and analysis, and drafting of research project reports.

Terms: The position will be a contractual one for one year (extendable for six months further) at a consolidated monthly salary of INR 25,000/-. The research assistant will be expected to physically work at NUJS, Kolkata for this duration.

Eligibility criteria: Any candidate with minimum LL.M. degree may apply for this position. Candidates with prior experience in the field of aviation law and/or related qualification will be preferred.
