AUDITORS' REPORT

TO,

- 1. We have audited the attached Balance Sheet of THE WEST BENGAL NATIONAL UNIVERISTY OF JURIDICAL SCIENCES, Dr. Ambedkar Bhavan, No.12 LB Block, Sector III Salt Lake City, Kolkata-700106 as on 31st March,2021 and related Income and Expenditure Account and Receipt and Payment account for the year ended on that date annexed thereto. These financial statements are the responsibility of the University Management. Our responsibility is to express an opinion on these financial statements based on our audit.
- 2. We conducted our Audit in accordance with auditing standards generally accepted in India. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement. An audit includes examining on a test basis, evidence supporting the amount and disclosures in the financial statements. An audit also includes the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation. We believe that our audit provides reasonable basis for opinion.
- 3. As per directives of State Government in the wake of COVID-19 pandemic, the operations of National University of Juridical Sciences were impacted due to shutdown of the offices following nationwide lockdown by the Government. The University has since resumed operations. The Management has considered the possible effects, if any, that may result from the pandemic on the carrying amounts of assets and liabilities after considering internal and external sources of information including the possible future uncertainties in the present economic conditions as at the date of approval of the financial statements. Given the uncertainties associated with the pandemic's nature and duration, the actual may differ from the estimates considered in the financial results. The University continues to closely monitor the rapidly changing situation.

4. We report that:

- a) The accounts have been prepared and our audit was conducted as per the provisions of section 24 of the West Bengal National University of Juridical Services Act. 1999 and regulations there under.
- b) We have obtained all the information and explanations, which to the best of our knowledge and belief were necessary for the purpose of our audit;
- c) In our opinion, proper books of accounts as required by law has been kept by the University, so far, as appears from our examination of those books.
- d) The Balance Sheet, the Income and Expenditure Account and Receipts and Payment Account dealt with by this report are in agreement with the books of Accounts, maintained by THE WEST BENGAL NATIONAL UNIVERSITY OF JURIDICAL SCIENCES.
- e) In our opinion, and to the best of our information and according to the explanations given to us, the said statement of accounts read together with the notes thereon give a true and fair view in conformity with the accounting principles generally accepted in India:
 - In the case of the Balance Sheet of the state of affairs of THE WEST BENGAL NATIONAL UNIVERSITY OF JURIDICAL SCIENCES as at 31st March 2021.
 - ii. In the case of the Income and Expenditure Account of the Excess of Expenditure over Income of THE WEST BENGAL NATIONAL UNIVERSITY OF JURIDICAL SCIENCES for the year ended on that date.
 - iii. In the case of the Receipts and Payment Account of the cash flows of THE WEST BENGAL NATIONAL UNIVERSITY OF JURIDICAL SCIENCES for the year ended as at 31st March 2021.

ACCOUNTING POLICIES & NOTES ON ACCOUNT

A) **ACCOUNTING POLICIES**

- 1. The Accounts of the year are prepared on the basis of cost and with fundamental assumption of going concern concept,
- 2. Items of expenditure are recognized on accrual basis. Incomes are recognized on cash / accrual basis.
- 3. Expenses for Employees Benefit are recognized on accrual basis except for Gratuity and Leave Encashment.
- 4. All depreciable Fixed Assets are shown at their original cost. Consequently the accumulated depreciation are reflected through Depreciation Fund account.
- 5. Depreciation is provided on all depreciable assets applying rates as per Income Tax Act 1961.
- The value of inventory is recognized at cost price following weighted average method of valuation of closing stock.



B) NOTES ON ACCOUNT

- The matter of rent payable by the Corporation Bank from July 2008 on wards is under review and in negotiation with Bank Authority. Pending finalization, the rent credited to WBNUJS account will not be taken in to consideration and the same will be kept in suspense account. The old of rent i.e. Rs. 40,000/- per months has been treated as income for 12 months (from April 2015 to March 2016) and the same credited to "Rent Bank Building.
- The matter of payment of Municipal Tax Bidhannagar Municipality as demanded by them is under negotiation with the Municipal Authority praying for total exemption from payment of any tax as the University is existing solely for education purpose and not for the purpose of profit.
- No provision has been made in the accounts towards Municipal Tax since 2015-16 as no demand has been received from the concerned authority.
- 4. Internal Audit should be introduced immediately to make the account department up to date and for better internal control.
- 5. We observe that the balance in the following CLSB bank accounts :
 - a. WBNUJS MAIN ACCOUNTS
 - b. WBNUJS STUDENTS FEE ACCOUNTS

In respective of which number of entries are awaiting to be accounted for several 'years. The University authority should take necessary step to reconcile the accounts.

- WBNUJS Students Fees account was reconciled and it was found that amount received as students paid through NEFT/RTGS was not fully reconciled.
- Advance given to staff and students should be adjusted within the particular Financial Year and adjustment should not be kept pending for a long time.
- 8. Reconciliation in respect of Gratuity Fund maintained with the LIC is pending.
- PF payable in respective of employers contribution along with interest amounting to Rs. 2,48,30,609.00 was provided for during the F.Y. 2020-21. PF payable as on 31st March 2021 amounting to Rs. 5,67,15,133.87 remains unpaid.



- 10. Staff Welfare Loan to the tune of Rs. 88,87,809.46 in respect of advances extended during previous financial years has been adjusted with Staff Welfare Fund during this current financial year.
- 11. No provision for Income tax is considered as the University is registered as a charitable institution u/s 12A(a) of the Income Act, 1961.
- 12. Schedules "1" to "15" form an integral part of accounts.
- 13. Depreciation Fund A/c is not reconciled with Depreciation Accumulated Fund A/c.
- 14. Figures of previous year have been regrouped and rearranged where necessary.
