In partial modification of Notice Inviting Tender dated 12.11.2022 for **Selection of Statutory and Internal Audit Firm**, the following amendment are made -

- 1) Tender for **Selection of Statutory Audit Firm** for a period of 2 years (Further 1 year may be extended) and Tender for **Selection of Internal Audit Firm** for a period of 2 years (Further 1 year may be extended). The scope of work will be defined as per rules and instruction of the Competent Authority to the eligible firms.
- 2) EMD to be submitted separately @ **Rs.10,000/-** for **Statutory Audit Firm** and @ **Rs.10,000/-** for **Internal Audit Firm**
- 3) Statutory Audit and Internal Audit cannot be performed by the same firm within the above mentioned time frames. Hence all are requested to submit separate bid for Statutory Audit and Internal Audit individually.
- 3) Financial Bid will be submitted in two different envelopes separately as subject of “**Financial Bid for Statutory Audit Firm**” and “**Financial Bid for Internal Audit Firm**”.
- 4) Omitted and replaced some portion of tender documents –
 - i) The term of Institute to be replaced with University
 - ii) Filing and Review of all statutory obligations at point no. xiii will be read as “Review of all statutory obligations”
 - iii) Average Annual Income of the firm considered in last 3 years ending on 31.03.2022 and the term of A-5 proforma in Annexure-II will be read as **Annexure-IV**
- 5) The last date of submission of bids of **all above mentioned tenders** will be extended upto **16-12-2022 (Friday)** upto **5.00 pm**.
