

- 6. The researcher having the highest score in the researcher's test shall be given a trophy, certificate, and a cash prize of INR 5,000/- (Indian Rupees Five Thousand Only).







#### I. DEFINITION

These Rules shall be called the '2<sup>nd</sup> AIU National Moot Court Competition Rules, 2023'.

Unless otherwise stated following shall be construed herein under as –

- i. "Administrator" shall mean Sister Nivedita University, Kolkata and The W.B. National University of Juridical Sciences, Kolkata.
- ii. "Appellant" shall include Appellant, Plaintiff, Petitioner, Complainant, Prosecution, Informant, etc.
- iii. "Bench" refers to the members duly invited to adjudge the oral rounds, collectively.
- iv. "Clarifications" means an explanation published by the Host University on the moot problem, at any point of time of the competition to a query posed by any participating team within the given deadline.
- v. "Compendium" means a compilation or collection of legal or other authorities that a participating team seeks to rely upon during the round of oral pleadings.
- vi. "Competition" means 2nd AIU National Moot Court Competition, 2023.
- vii. "Host University" shall have the same meaning as "Administrator" for this edition of the Competition.
- viii. "Moot Proposition" means the Proposition released by the Organizers and shall include any subsequent clarification(s) as and when issued by the Organizers.







- ix. "Oral Score" means the scores given by the judge to a particular orator of the participating team pleading before it during the round of oral assessment.
- x. "Orator" means one of the two designated speakers in a participating team.
- xi. "Organizers" means the SNU Moot Court Society and NUJS Moot Court Society.
- xii. "Participating Team" means the team which is eligible to participate in the competition after completion of the registration procedure.
- xiii. "Participating Institution" shall be presumed to be the parent institution of the participating teams.
- xiv. "Researcher" means a team member who will sit with the teams at the Oral Rounds but shall not be permitted to address the Court during the Oral Rounds. The Researcher may however, be permitted to pass notes to the Speakers at the discretion of the Judges. The researcher shall be the only person allowed to take the Researchers Test.
- xv. "Respondent" shall include Defendant, Respondent, Defence, etc.
- xvi. "Rules" means the AIU National Moot Court Competition Rules.
- xvii. "Team Code" means a unique code assigned by the Host University to the registered participating team.
- xviii. "Written Score" means the scores given by the organizers to a particular participating team on the written submissions submitted by them according to the rules of the Competition.







xix. "Written Submissions" means the memorandum of written submissions (memorials) submitted by any participating team according to the rules of the Competition.







#### II. GENERAL RULES

#### 1. Date and Venue of the Competition

The 2<sup>nd</sup> AIU National Moot Court Competition, 2023 will be held from 17<sup>th</sup> March 2023 to 19<sup>th</sup> March 2023 at the campus building of Sister Nivedita University, DG Block(Newtown), Action Area I, 1/2, Newtown, New Town, Kolkata 700156, West Bengal AND The W.B. National University of Juridical Sciences, 12, LB Block, Sector III, Bidhannagar, Kolkata 700098, West Bengal.

#### 2. Date of Release of Moot Proposition:

The Moot Proposition shall be released on 19th January 2023.

#### 3. Team Eligibility and Composition:

- Participation is restricted strictly to bona fide law students pursuing the three years or five years LL.B. degree course in any institution in India. Students doing their LL.M. and Diploma courses are not eligible for participation.
- ii. Only one team is permitted to participate from each participating institution.
- iii. The team must consist of three members, two members shall be designated as 'Speakers' and the third member shall be designated as 'Researcher'.

#### 4. Registration Procedure:

- iii. Allotment of Team Code: Every team which has successfully completed the Registration requisites under the Rules shall be allotted a unique code after the closure of the Registration for the Competition. Once the Code is allotted, every team must use only the team code for any further communication with the Organizers during the course of the Competition.
- iv. **Change in Team Composition:** Any change in team composition must be intimated to the Organizer at the earliest. Any change must be accompanied with a freshly filled registration form and an authority letter duly signed by the head of the institution.

- ii. The Dress Code for the Inauguration, Researcher's Test, Oral Rounds and Valedictory & Prize Distribution shall strictly be:
  - a) **For Gentlemen** Western Formals (White formal shirt with black formal pants and a black blazer); and
  - b) **For Ladies** Western Formals (White formal shirt with black formal pants/black formal skirt and a black blazer) or Indian Formals.

#### IV. WRITTEN SUBMISSION

#### 1. Strict Adherence to Rules Regarding Written Submissions:

All requirements have to be strictly followed. Non-adherence to the same will attract penalties as provided under the Rules.

#### 2. Written Submission to be prepared from Both Sides:

Each team must prepare Written Submission for both sides to the dispute.

#### 3. Submission of Soft Copy of Written Submission:

- i. The soft copies of the written submission from each side should reach the Organizers at aiunationalmootcourt@gmail.com in ".pdf" format latest by 20<sup>th</sup> February 2023 before 6 PM.
- ii. Written Submissions from both sides shall be sent in a single e-mail.
- iii. A penalty of 1 mark shall be imposed in case the written submission is submitted in any other format or by multiple emails by the team.
- iv. The team submitting the soft copy 2 days after the last date of the submission of the soft copy of the written submission will be disqualified from the competition.

#### 4. Submission of Hard Copy of Written Submission:

i. Three copies of the written submission from both sides should reach the Organizers at the below-mentioned address by 6<sup>th</sup> March 2023 (Only through Indian Post's Speed Post) –

ii. The teams must carry copies of the written submission from both sides for their own reference.

#### 5. No Difference between Soft Copy and Hard Copy of Written Submission:

The hard copy of written submission must be exact replica of the soft copy submitted with the Organizers. Any difference in the same will result in disqualification from the Competition.

#### 6. Penalty for Late Submission:

- i. A penalty of 1 mark per hour per side shall be deducted in case of delay in the submission of soft copy of written submission.
- ii. A further penalty of 2 mark per day per side shall be levied in case of delay in submission of hard copy of written submission.

#### 7. General Conditions for Written Submissions:

i. The Written Submissions must not contain any form of identification apart from the team code. If any such identification or mark, symbol, etc. which has the effect of identifying the team is found on the written submission, then it shall result in instant







disqualification of the participating team.

- ii. Appellants Written Submissions are required to have a Blue cover and the Respondents Written Submissions are required to have a Red cover.
- iii. A penalty of 1 mark per side shall be levied in case the team uses the wrong cover for written submission.

#### 8. Guidelines for Formatting:

- i. Written Submission Structure: The Written Submission must contain following contents:
  - a. Cover Page The cover page shall contain the case title, side of the written submission, year of competition, name of the forum and team Code on top right corner;
  - b. Table of Contents;
  - c. List of Abbreviations;
  - d. Index of Authorities: The Index of Authorities must list all the authorities cited in the Written submission. The Index must indicate the page number(s) and/or the paragraph number(s) of the Written submission in which the authority is cited;
  - e. Statement of Jurisdiction;
  - f. Statement of Material Facts: The Statement of Material Facts must contain a concise statement of the relevant facts of the dispute. As far as may be, the Statement of Facts should be limited to the stipulated facts and legitimate inferences which can be drawn from those facts. Argumentative facts are prohibited. Statement of Facts shall not exceed 2 pages. Noncompliance will result in a penalty of 1 mark for each exceeded page;
  - g. Issues Raised;







- h. Summary of Arguments: The Summary of Arguments should contain a summary of the substance of the arguments, and should not merely be a reproduction of the various headings and sub-headings of arguments. The Summary of Arguments shall not exceed 2 pages. Non-compliance will result in a penalty of 1 mark for each exceeded page;
- i. Pleadings / Arguments Advanced:
  - a) All legal arguments must be limited to the Pleadings/Arguments Advanced section of the written submission. Non-compliance will result in a penalty of 2 marks.
  - b) The Pleadings/Arguments Advanced and Prayer must not exceed 20 pages. Non-compliance will result in a penalty of 1 mark per exceeded page;
- j. Prayer.

Non-compliance with respect to sections (a) to (h) and (j) will result in a penalty of 1 mark for each missing section. Non-compliance with respect to section (i) will result in the Written Submission not being considered for evaluation at all.

- ii. **Team Code:** The team code must be ascribed on the top right corner of the cover page. The code must be succeeded by the side for which the written submission is prepared. The teams must use "A" for Appellant, P for "Appellant" and R for "Respondent." For example: in case the Team Code is TC-100 the team must write "TC-100A" in case of written submission for Appellant and "TC-100R" in case of written submission for Respondent.
- iii. **Margin:** The Written submission must maintain an equal margin of 1 inch on all sides. Non-compliance will result in a penalty of 1 mark per each side of Written Submissions.







- iv. **Font, size and line spacing:** The text font should be Times New Roman or Garamond, size 12 and must be in 1.5 line spacing. Non-compliance will result in a penalty of 0.5 mark per incorrect format of font, size and line spacing with a maximum of 2 marks per page of the Written Submissions.
- v. **Footnotes:** The footnotes must be in font Times New Roman or Garamond, size 10 and singly spaced. There should be double line spacing between two footnotes. The Bluebook: A Uniform System of Citation (20th Edition) should be followed in the written submission throughout. Non-compliance will result in a penalty of 1 mark per page. Substantive/Speaking footnotes are strictly prohibited. Non-compliance will result in a penalty of 1 mark per substantive citation.
- vi. **Header and Footer:** The font used for the header/footer, if any, shall be Times New Roman or Garamond, size 10, 1 spacing. Non-compliance will result in a penalty of 1 mark per page of the Written Submissions.
- vii. **Page Limit:** There is no maximum page limit on the Written Submissions and the pleadings/Arguments Advanced shall be of a maximum of 20 pages. No annexures, photographs, exhibits, etc. should be added to the written submission.
- viii. **Binding of Written Submission:** The teams shall bind their written submission with spiral binding only.







ix. The written submissions shall be marked on a scare of 100 marks and the parameters which are laid down as under:






#### V. ORAL PLEADING ROUNDS

#### 1. General Procedure:

- i. Teams are requested to submit three (3) hard copies of the Written Submissions for both sides to be submitted on or before 06<sup>th</sup> March 2023 and carry extra hard copies for their own reference during oral rounds.
- ii. The language to be used during the Oral Pleading Rounds shall be exclusively English.
- iii. The Competition shall consist of the following rounds:



iv. During each of the abovementioned rounds, the order in which the teams shall present their arguments, is as follows:







- a. Appellant Speaker 1
- **b.** Appellant Speaker 2
- c. Respondent Speaker 1
- d. Respondent Speaker 2
- e. Rebuttal: Appellant Any one of the two Speakers
- **f.** Sur-rebuttal: Respondent Any one of the two Speakers.

Sur-rebuttal may be permitted only at the discretion of the Judges.

- v. The Best Speaker Award shall be determined on the basis of the individual aggregate score of the speaker taken only from the Preliminary Rounds. Individual Aggregate Score shall be determined as the sum of the following:
  - a) Score of Speaker in Preliminary Round I;
  - b) Score of Speaker in Preliminary Round II; and
  - c) Half of Memorial Score
- vi. The Researcher shall be allowed to sit with the teams at the Oral Rounds but shall not be permitted to address the Court during the Oral Rounds. The Researcher may however, be permitted to pass notes to the Speakers at the discretion of the Judges. Such notes shall be passed through the court clerks present in the court room. The researcher shall be the only person allowed to take the Researchers Test.
- vii. Teams are not permitted to raise issues in the Oral Rounds that have not been submitted in the Written Submissions.
- viii. The use of mobile phones, laptops, or any other electronic gadgets is strictly prohibited during the Oral Rounds, subject to the discretion of the judges.







- ix. Participants may use their own bare acts, printouts and commentaries provided that anonymity is not violated during the Rounds.
- x. Participants shall ensure that anonymity is not violated while passing on any material to the Judges. No mark, name, seal, symbol or logo of the institution/college/university must be present. Participants must ensure that the same is rendered unrecognizable.
- xi. The decision of the Judges as to the marks allotted to each team shall be final and binding.

#### 2. Splitting of Time in between Speakers:

- i. Each side shall get a maximum time of 30 minutes (45 minutes for Final Round) to present their arguments of which no Speaker shall be permitted to address the Court for more than 20 minutes (30 minutes for Final Round). The time limit is inclusive of the time for Rebuttal or Sur-rebuttal respectively. The maximum time for Rebuttal is 2 minutes and the maximum time for Sur-rebuttal is 1 minute. Each speaker is required to speak for a minimum of 10 minutes (15 minutes for Final Round) inclusive of time taken for Rebuttals and Sur-rebuttals.
- ii. Teams shall notify the Court Clerks of the division of time between the 2 Speakers (including time reserved for Rebuttal & Sur-rebuttal) 10 minutes prior to the commencement of the Rounds.
- iii. If Speaker 1 exceeds his/her reserved time, the additional time taken shall be deducted from the time reserved by Speaker 2. Similarly, if Speaker 2 exceeds his/her reserved time, the additional time taken shall be deducted from the time reserved for Rebuttals/Sur-Rebuttals as the case may be. This rule may not be followed if the







additional time is awarded at the discretion of the Judges to not be deducted from the time of the subsequent Speaker.

- iv. While granting additional time, if the additional number of minutes granted is not specified by the Judges, it shall be presumed that the additional time granted is 2 minutes.
- v. The finality of the decision as to the time structure and the right to Rebut or Sur-rebut shall vest with Judges.

#### 3. Compendium:

- All relevant case laws and statutory material to be passed on to the Judges during the Oral Rounds may be submitted in the form of a Compendium 10 minutes prior to the commencement of the Rounds to the Court clerks.
- ii. Participants are also permitted to pass on relevant material to the Judges, at their discretion, any time after the commencement of the Rounds and before its completion.
- iii. Participants shall ensure that anonymity is not violated while passing on any material to the Judges. No mark, name, seal, symbol or logo of the institution/college/university shall be present. Participants must ensure that the same is rendered unrecognizable.







#### 4. Exchange of Written Submission

- i. The exchange of Written Submissions shall take place prior to the Oral Pleading Rounds.
- ii. Teams are prohibited from making any marks on the opponent's Written Submissions thus exchanged. Teams are also prohibited from making any copies of the opponent's Written Submission, electronically or otherwise.
- iii. The opponent's Written Submissions shall be returned to the Court clerks after the completion of each Round.

#### 5. Preliminary Rounds:

- i. Every team shall argue twice in the Preliminary Rounds, once for the Appellant and once for the Respondent.
- ii. No two teams shall face each other more than once in the Preliminary Rounds.
- iii. Draw of Lots: The match up of teams in Preliminary Rounds shall be determined on the basis of draw of lots. Draw of lots shall take place on 17<sup>th</sup> March 2023.

#### 6. Scoring in the Oral Rounds:

#### 1. The Preliminary Rounds

1.1. There will be two (2) Preliminary Rounds to ensure that each team is given the opportunity to argue from both sides of the Proposition.







- 1.2. The fixtures for the Preliminary Rounds shall be determined by draw of lots.
- 1.3. For the Preliminary Rounds, the winner of each such round shall be determined on the basis of the criteria of evaluation of the memorials scores and the speaker scores, as mentioned in the Rules below.
- 1.4. Each Round shall be decided by awarding points on six (6) different criteria.
- 1.5. If the difference in Memorial Scores of the teams facing each other is equal to or exceeds seven percent (7%) of the maximum obtainable score, then three (3) points are to be awarded to the team with the superior Memorial Scores. If the difference in memorial scores is less than seven percent (7%) of the maximum obtainable score, then two (2) points are to be awarded to the team with the superior Memorial Scores and one (1) point is to be awarded to the other team. If there is no difference in Memorial Scores of the two teams then the teams will be awarded 1.5 points each.
- 1.6. If the difference in Speaker Scores of the teams facing each other as awarded by each judge in the Preliminary Round is equal to or exceeds seven percent (7%) of the maximum obtainable score, then three (3) points are to be awarded to the team with the superior Speaker Scores. If the difference in Speaker Scores is less than seven percent (7%) of the maximum obtainable score, then two (2) points are to be awarded to the team with the superior Speaker Scores and one (1) point is to be awarded to the other team. If there is no difference in Speaker Scores between the teams, then the teams will be awarded 1.5 points each for that judge.
- 1.7. If two or more teams have the same cumulative points, then the team with higher aggregate score shall be ranked higher. If two or more teams have the same cumulative points and same aggregate score, the team with the higher cumulative speaker scores shall be ranked







higher. If two or more teams have the same cumulative points, same aggregate score and same cumulative speaker scores, then the team with the higher gross memorials score, i.e., the score of the memorials without deducting penalties, shall be ranked higher.

### 2. The Quarter Final Rounds

2.1. The eight (8) teams that proceed to the Quarter Final Rounds, as determined by the Rules above, shall each argue only ONCE for the side allotted by a draw of lots. The fixtures for the Quarter Final Rounds shall be as follows:

Rank 1 v. Rank 8 (Quarter Final Round I)

Rank 2 v. Rank 7 (Quarter Final Round II)

Rank 3 v. Rank 6 (Quarter Final Round III)

Rank 4 v. Rank 5 (Quarter Final Round IV)

- 2.2. For the Quarter Final Rounds, each team shall argue ONCE for the side allotted by a draw of lots.
- 2.3. Four (4) teams shall qualify for the Semi Final Rounds on a knock out basis, i.e., the winner of each Quarter Final Round shall qualify to the Semi Final Rounds. The knockouts will be decided on the basis of the rules mentioned above (1.6), i.e. based on the score of the oral rounds only.
- 2.4. In case of a tie, the team with higher aggregate speaker scores will be declared the winner for that round. If the aggregate speaker scores of the teams are the same, then the team with higher gross memorial score i.e., the score of the memorial without deducting penalties shall be ranked higher.







### 3. The Semi Final Rounds

3.1. The four (4) teams that proceed to the Semi Final Rounds, as determined by the Rules above, shall each argue only ONCE for the side allotted by a draw of lots. The fixtures for the Semi Final Rounds shall be as follows:

Winner of Quarter Final Round I v. Winner of Quarter Final Round IV
Winner of Quarter Final Round II v. Winner of Quarter Final Round III

- 3.2. Two (2) teams shall qualify for the Final Round on a knock out basis, i.e., the winner of each Semi Final Rounds shall qualify to the Final Round. The knockouts will be decided on the basis of the rules mentioned above (1.6), i.e. based on the score of the oral rounds only. The bench-strength for this round shall be an odd number but not one (1).
- 3.3. In case of a tie, the team with higher aggregate speaker scores will be declared the winner for that round. If the aggregate speaker scores of the teams are the same, then the team with higher gross memorial score i.e., the score of the memorial without deducting penalties shall be ranked higher.
- 3.4. Two (2) teams which shall not qualify for the final round shall be declared 2<sup>nd</sup> Runner Up and 4<sup>th</sup> Place respectively. Among those two teams, the team with higher aggregate speaker score will be declared as 2<sup>nd</sup> Runner Up and the other team shall be declared as 4<sup>th</sup> Place. In case of a tie, clause 3.3 shall be made applicable.







# 4. The Final Round

- 4.1. The two (2) teams that proceed to the Final Round, as determined by the Rules above, shall each argue only ONCE for the side allotted by a draw of lots.
- 4.2. The team which wins the Final Round shall be declared as the 'Winning Team'. The other team shall be declared as the 'Runners-Up Team'.
- 4.3. The winner of the Final Round shall be determined on the basis of the rules mentioned above (1.6), i.e. based on the score of the oral rounds only. The bench-strength for the Final Round shall be an odd number but not one (1).
- 4.4. In case of a tie, the team with higher aggregate speaker scores will be declared the winner for that round. If the aggregate speaker scores of the teams are the same, then the team with higher gross memorial score i.e., the score of the memorial without deducting penalties shall be ranked higher.

# 7. Scouting:

- i. Scouting is strictly prohibited.
- ii. Any person may submit a complaint regarding Scouting to the Organizers.
- iii. Teams found scouting shall be disqualified immediately.

# 8. Delay in Appearance/Presentation:

If a team scheduled to take part in any Round does not appear within 10 minutes of the scheduled time, the other team present shall be allowed to submit ex-parte.

### VI. RESEARCHERS TEST

- 1. The Researcher's Test shall be conducted on 17<sup>th</sup> March 2023.
- 2. In each team consisting of three members, only the member designated as Researcher shall take part in the test.
- 3. Participants are requested to write only the Team Code on the question paper.
- 4. The Researcher's Test shall be objective with questions based on the applicable law, precedents and facts pertaining to the Moot Proposition.
- 5. The duration of the Researcher's Test shall be 60 minutes.
- 6. The Researcher's test shall consist of 50 (fifty) objective type questions carrying 2 (two) marks each. Each wrong answer would lead to a deduction of .50 marks.
- 7. No additional material such as the bare text of Acts, Written Submissions, etc. apart from stationery may be brought by the participant to the test and no such material shall be provided by the Organizers.
- 8. Score of the Researcher's Test shall be computed as the total of Score in Researcher's Test. [Note: In case two or more students score the same aggregate marks in the Researcher's test, higher rank will be awarded to the student scoring more marks in the written submission of the memorials.]
- 9. The Winner of the Test shall be determined by the highest score attained.







### VII. AWARDS

The following awards shall be awarded in the Competition:

- i. Best Team: the team winning the final round of the Competition shall be given a trophy, medals, certificate and cash prize of INR 30,000/- (Indian Rupees Thirty Thousand Only).
- ii. Runners Up: the runners up team in the final round of the Competition shall be given a trophy, medals, certificate and a cash prize of INR 20,000/- (Indian Rupees Twenty Thousand Only).
- iii. Second Runner Up: the team standing third in the semi final rounds shall be given a trophy, medals, certificate and a cash prize of INR 10,000/- (Indian Rupees Ten Thousand Only).
- iv. Best Memorial: The team having the highest average written submission score from both sides shall be given a trophy, certificate and a cash prize of INR 10,000/- (Indian Rupees Five Thousand Only).
- v. Best Speaker: The speaker having the highest score in the preliminary rounds shall be given a trophy, certificate and a cash prize of INR 5,000/- (Indian Rupees Five Thousand Only).
- vi. Best Researcher: The participant having the highest score in the researcher's test shall be given a trophy, certificate and a cash prize of INR 5,000/- (Indian Rupees Five Thousand Only).
- vii. Certificates of merit shall be given to all the teams qualifying for Quarter-finals and beyond.







- viii. Certificate of participation shall be given to all the participating teams.
- ix. The awards, certificates of merit and certificates of participation shall be given during the valedictory ceremony to be conducted on 16th February, 2020. No certificate will be given to the team before or after the valedictory function.







# VIII. JURY OF APPEALS

- The Jury of Appeal is constituted to ensure transparency in the competition and accountability of the organizers, with respect to any dispute in the '2<sup>nd</sup> AIU National Moot Court Competition' on the spot.
- ii. If a Team believes that the Rules of the Competition have been violated at any stage of the Competition, the Team shall, within half an hour after the completion of the round in which the alleged violation has occurred, register a complaint with the Jury of Appeal of the Competition at aiunationalmootcourt@gmail.com.
- iii. All the decisions and direction approved by the aforesaid committee shall be binding for all the team participating in the competition.







# IX. ACCOMMODATION AND FOOD

- Accommodation and food shall be provided to the participating teams for the duration of the competition, i.e., from 17<sup>th</sup> March 2023, 12:00 PM till 20<sup>th</sup> March 2023 12:00 PM.
- ii. All facilities shall be provided only to the registered members of a team and no additional members, parents, observers, coaches or faculty advisors shall be accommodated.







#### X. MISCELLANEOUS

#### 1. General Etiquettes:

- Participants are expected to behave in a dignified manner and not to cause any inconvenience to the Organizers, the Judges of the Competition or any of the other participants.
- ii. The Organizers reserves the right to take appropriate action for any unethical, unprofessional or immoral conduct, which may include direct elimination from the competition.
- Facilities such as photocopying, library usage, internet connectivity, etc. may be provided subject to the convenience of the Organizers and will be informed to the teams closer to the commencement of the Competition. Irrespective, participants are requested to make their own arrangements for the same.
- iv. Administrator shall not be responsible for any loss of belongings of the team during the competition.

#### 2. Interpretation of Rules & Regulations:

- i. The Organizers reserves the right to take decisions on any matter not mentioned in the Rules of the Competition through Jury of Appeals. Any such decision taken by the Organizers / Jury of Appeals shall be final and binding.
- ii. The Organizers / Jury of Appeals reserves the right to interpret any of the Rules of the Competition. Such interpretation shall be final and binding.







#### 3. Other Clauses

- i. If any one member of a team is notified or informed of any detail or information concerning the Competition, it shall be deemed as if the said team as a whole has been duly notified or informed.

- 1. In January 2021, during the peak of the SarsCov2 global pandemic, M/s. Hartmann-Klein, a well-known pharmaceutical multinational, launched its much-anticipated Maxbio Rapid Covid Antigen Test Kit worldwide. It was deliberately designed in a universally "user-friendly" manner, priced reasonably, and made available in what was deemed to be in bulk retail scale across both developed and developing countries, including India, with localised rollouts being expected by February/March 2021.
- 2. By March-April 2021 however, India was in the throes of a virulent second wave of the aforementioned coronavirus attack. With the situation deteriorating day by day the Government of Indraprasth (UT) took countermeasures by issuing a restrainment order dated 17.04.2021 (The copy of the order is marked as Exhibit I). Despite such measures, the magnitude of the pandemic increased with basic essentials such as beds, oxygen and essential palliative medicaments falling short of requirements. On account of this abrupt development, the resultant chaos, market panic and the subsequent closure of inter-state/intra-state borders on several occasions, delivery and smooth dissemination of said kits were disrupted, delayed, and suspended in multiple instances, with evidently, the hardest hit being those potential patients for whom this would have served as an invaluable aid to providing basic primary-level diagnosis and further care wherever necessary.







- 3. The (now) late Mr. Ashoke Narayan, had, at the time, recently retired from active service, and with his wife, Mrs. Deepa Narayan, had moved back to his family residence in Indrapuram (Indraprasth South). Their only child, Jaya, is based out of Chicago, and indefinitely stranded there on account of the pandemic, Mr. & Mrs. Narayan have been managing on their own with the assistance of their resident house help.
- 4. A generally fit person for his age, Mr. Narayan had been a chronic diabetic requiring once-in-a-year periodic check-up. However, the condition has always been in full control and had never interfered with his daily activities and overall productivity. But it was an established fact that this pre-existing co-morbidity, however mild, did indeed render him particularly susceptible to contracting the Covid-19 virus, and accordingly, the Narayans observed all manner of prescribed precautions.
- 5. However, around mid-April, Mr. Narayan suspected that he might perhaps have taken ill, he was hard-pressed to procure any reliable medical diagnostic service, the virulence and scale of the pandemic having left the vast majority of healthcare providers across the spectrum, manifestly overwhelmed in the face of massive casualties and fatalities. This was compounded by inadequate/unavailable basic essentials for care, rendering patients and potential patients like Mr. Narayan utterly helpless.
- 6. Vaccines having yet to achieve mass national-level dissemination, Mr. Narayan was left with no recourse but for paracetamols, and bed rest for the most part.
- 7. It was in early July when, the Narayans were awaiting their turn to be vaccinated against the virus, that, Mr. Narayan suffered a major cerebral attack, which rendered him completely prone. His condition began to showcase rapid deterioration with partial paralysis beginning to set in, but the nation still being deep in the throes of the existing coronavirus crisis, all other cases were formally/informally relegated to secondary priority status.







- 8. Under the circumstances, and desperate to stall any further regression, Jaya made a personal request to her erstwhile school friend, Aryaa Chatterjee, now a Senior Resident at Indrapuram's Navjeevan Superspeciality Hospital Ltd., to try and mobilise whatever internal resources she could, so that her father might be able to avail of some "special" attention on an urgent basis.
- 9. Dr. Chatterjee, having successfully convinced her immediate senior, and Chief Surgeon, Dr. Rakesh Malik, the facility was amenable to expediting Mr. Narayan's wait, should his family be open to considering a course of treatment & procedure, which, while widely acclaimed in leading medical schools the world over, was still in the initial days of implementation here in India.
- 10. Said procedure, deemed path-breaking in advanced neurosurgery, involved the use of Theia, a cutting-edge AI precision product [Theia, whilst being fully portable, easily assemblable, and relatively sturdy, carries within itself the strength of a top-grade electron microscope, and until date, has been tried out at various leading medical research institutes mainly for keen preoperative detection, with universally excellent feedback] and Dr. Anna Malik, a widely revered senior neurosurgeon who also happened to be one of the several leading lights in the profession vouched for the fact that having been working with Theia for the past many months, had thus far not experienced even one occasion of error / sub-par performance.
- 11. With Mr. Narayan having already lost valuable days, and consequently in a gravely delicate condition, the surgical team unanimously concurs that time is indeed of the essence, and that a tremendously high degree of precision being called for here, utilising Theia for micro-detection during surgery, would certainly not be uncalled for.







- 12. The procedure commences, Theia meets all expectations, and no effort or skill is spared, yet the patient, Mr. Narayan expires before the surgery could be formally declared as successfully concluded, and whilst technically still on the table.
- 13. Once the details of this emergency procedure is brought to the knowledge of Mr. Narayan's survivors, his widow, Mrs. Deepa Narayan decides to bring charges against Dr. Malik, as well as the Navjeevan Group's Governing Body, as well as the Indrapuram Municipal Corporation for grossly inadequate handling of the concerns of citizens during a pandemic situation.
- 14. A Civil Writ Petition is duly filed, and in August 2021, comes up for hearing before the Indraprasth High Court the very next month.
- 15. The three individual Respondents enter appearance. Following a lengthy hearing, the Single Judge found in favour of the Petitioner. In summary:
  - (i) Mr. Narayan's plight, when read with the government-vetted statistics of live cases, recoveries and fatalities, brings home the enormity of the disaster that the country has had to weather, as a consequence of a myopic collusion between the national & state executive, the implementers, and Big Pharma, where despite handy cutting-edge technology having already come into being, precious little could ultimately be done to actualise the same at a time of crisis and this, in spite of there having been a number of apparently bespoke legislations and policy documents in place, something that if regarded as an instance of negation of fundamental rights of the ill, the deceased, and their survivors,—would certainly not be an overstatement.







- (ii) Dr. Malik, as well as the Navjeevan Group's Governing Body are found liable for having "irresponsibly overstepped the brief", and thus have fallen guilty of gross negligence and consequential medical malpractice.
- (iii) The Indrapuram Municipal Corporation for abysmally poor handling and provision of basic medical infrastructure during an emergency situation, namely a global pandemic.
- 16. Aggrieved, the Respondents appeal to a Division Bench of the Indraprasth High Court. The Division Bench partially reverses the ruling of the Single Judge, citing:
  - (i) While the decision to rely so very utterly on artificially intelligent aids for surgical procedures of this nature may have indeed been premature, the procedure proper can be seen to be both, Bolam and Bolitho compliant.
  - (ii) Given the unprecedented scale, sweep and sheer force of the second wave of the Covid-19 pandemic that India witnessed in the spring/summer of 2021, any municipal corporation may quite understandably be excused on the grounds that they were all struggling to simply cope with the reality on the ground, and as such, were trying their best to do what could be done with the government allocated resources during a situation no less than a calamitous disaster.
- 17. In light of the above, Mrs. Deepa Narayan has proceeded to file a Special Leave Petition before the Supreme Court of India seeking to challenge the Division Bench's order. The Hon'ble Supreme Court grants leave u/Article 136, and is pleased to hear the matter in exhaustive detail.

# GOVERNMENT OF INDRAPRASTH (UT) INDRAPRASTH DISASTER MANAGEMENT AUTHORITY

No. F.5/04/2021/pt file-II/28/

#### ORDER

Whereas, the Indraprasth Disaster Management Authority (IDMA) is satisfied that the Indraprasth (UT) is threatened with the spread of COVID-19 epidemic, which has already been declared as a pandemic by the World Health Organisation, and is considered it necessary to take effective measures to prevent it spread in Indraprasth (UT).

- 1. And whereas, the situation of COVID-19 in Indraprasth (UT) has been reviewed and it has been observed that there has been a very sharp increase in COVID-19 cases along with very high positivity rate over the last few days and therefore, it is felt that in order to contain the fire spread of virus, curfew needs to be imposed in the territory of Indraprasth (UT), except for essential activities/services, as an emergency measure, in order to break the transmission chain of COVID-19 virus and for overall well-being and safety of people of Indraprasth (UT).
- 2. Now, therefore, in exercise of powers conferred under section 22 of the Disaster Management Act, 2005, the undersigned, in his capacity as Chairperson, State Executive Committee, IDMA, hereby directs that there shall be curfew on the movement of individuals (except for exemptions given below in this order) in the territory of Indraprasth (UT) with effect from 10 PM on 18.04.2021 (Sunday) till further order. Following categories of individuals are however exempted from the above restriction of movement during curfew:







- a) Officers/officials of Government of India, its autonomous/subordinate offices and PSUs, on production of valid I card and as per the restrictions imposed by Government of India.
- b) Offices of Government of Indraprasth (UT)/Autonomous Bodies/Corporations shall remain closed except those involved in essential and emergency services such as Health and Family Welfare and all related medical establishments, police, prisons, home guards, civil defence, fire and emergency services, district administration, pay an account of his, electricity services, water and sanitation, public transport, disaster management and municipal services.
- c) All Judicial officers/officials/staff members of all thoughts of Indraprasth (Hon'ble Supreme Court of India/ Hon'ble High Court of Indraprasth/ District Courts/ Tribunals) on production of valid I card/permission letters issued by the Court Administration.
- d) All private medical personnel such as doctors, nursing staff, paramedical, etc. and other hospital services (such as hospitals, diagnostic centres, testing laboratories, clinics, pharmacies, pharmaceutical companies, medical oxygen suppliers and other medical and health services including incidental services such as supply of medical instruments and consumables, sanitation, security, etc.), on production of valid I card.
- e) Pregnant women and patients for getting medical / health services along with attendant, on production of valid I card / doctor's prescription / medical papers.
- f) Persons who are going for COVID-19 testing or vaccination, on production of valid I card.
- g) Person coming from/going to airports/railway stations/bus terminal allowed to travel on production of valid ticket.







- h) Officers/officials function in the offices of diplomats of various countries as well as persons holding any constitutional post on production of valid I could.
- i) Electronic and print media on production of valid I could.
- j) Persons/ students shall be allowed to appear in examination on production of valid admit card. The examination staff deployed for exam duties shall be allowed to travel on production of valid I card.
- k) There shall be no restriction on inter-state and intra-state movement / transportation of essential goods. No separate permission / e-pass will be required for such movements.
- Movement of persons related to commercial and private establishments / offices providing following services / commodities shall only be allowed:
  - i. Shops dealing with food, groceries, fruits and vegetables, dairy and milk booths, meat and fish, animal fodder, pharmaceuticals, opticians, medicine and medical equipments, newspaper distribution.
  - ii. Banks, insurance offices and ATMs, SEBI/ stock related offices.
  - iii. Telecommunications, Internet services, broadcasting and cable services, IT and IT enabled services.
  - iv. Delivery of all essential goods including food, pharmaceuticals, medical equipments for e-commerce.
  - v. Petrol pumps, LPG, CNG, petrol and gas related storage outlets.
  - vi. Water supply, power generation, transmission and distribution units and services.
  - vii. Coal storage and warehousing services.
  - viii. Private security services.







- ix. Manufacturing units of essential commodities.
- x. Manufacturing units of non-essential commodities having on-site workers.
- xi. Production units or services, which require continuous process.
- xii. Delivery of food by way of home delivery / take away by restaurants / eateries.
- m) Religious places shall be permitted to open, but no visitors shall be allowed.
- 3. The movement of the individuals specified above in para- 2(l) and 2(m) shall be allowed only with the possession of e-pass, which can be obtained by applying on the website www.indraprasth.gov.in. However, movement on foot would be allowed to avail these essential services without e-pass. The concerned Municipal Commissioner shall be responsible for issuing of e-passes for above activities and for overall implementation of these measures in their respective jurisdiction. All other line department officials in the specified area will work under the directions of concern Municipal Commissioner. Further, e-pass obtained and possessed by a person for movement connected to essential goods and services during night curfew / weekend curfew shall also be valid for aforesaid curfew period.
- 4. Public transportation such as Metro (up to 50% seating capacity) / Public Buses (up to 50% seating capacity) / Autos & e-rickshaws, (up to 2 passengers) / Taxis, Cabs (up to 2 passengers) shall be allowed to function within a stipulated time for the transportation of only above-mentioned categories of people during curfew, as per prescribed Protocols/ issued by the government in this regard. No standing passengers shall be allowed.
- 5. Further, during curfew, movement persons for marriage related gatherings up to 50 persons (on production of soft or hard copy of marriage card) and funeral/last rites related gatherings up to 20 persons is continue to be allowed.
- 6. Except aforementioned exempted / allow movements and activities, all other private offices/establishments, shops, shopping centres, malls, weekly markets, manufacturing units,







educational and coaching institutes, cinema and theatres, restaurants and bars, auditoriums/assembly halls, entertainment/amusement/water parks, public parks and gardens, sports complexes, gyms, spas, barber shops, saloons, beauty parlours, swimming pools (except being used for training of sports persons for participation in national and international events), construction activities (except where labourers are residing on site) etc. shall remain closed during curfew.

- 7. All social/ political/ sports/ entertainment/ academic/ cultural/ religious/ festival related another gathering and congregations shall be prohibited.
- 8. Stadia shall be permitted to open for organizing National / International sports event without spectators.
- 9. All Municipal Commissioners and all authorities concerned shall ensure strict compliance of this order and shall adequately inform the sensitize and field functionaries about these instructions for strict compliance, in letter and spirit. All enforcement authorities to note that these restrictions fundamentally relate to movement of people, but not to that of essential goods / services.
- 10. In case any person is found violating the aforesaid instructions, the defaulting person(s) shall be proceeded against as per the provisions of section 51 to 60 of Disaster Management Act, 2005, section 188 of IPC and other applicable laws.
