4. The contractor shall employ technically qualified and competent supervisors for the work who shall be available throughout the working hours to receive and comply with instructions of the owner. The contractor shall employ experienced persons having appropriate skill or ability to perform their job efficiently. The contractor shall comply with the provisions of all labour legislation act.
5. If the work is not completed to the satisfaction of the University within the stipulated period, no extension of time can be permitted under any circumstance. Penalty for delay in completion of work will be levied @ 0.5% of the value of order per day. Max 10% of Total Work Order value can be deducted as penalty.

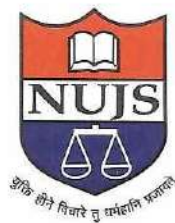

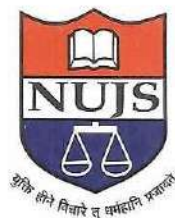

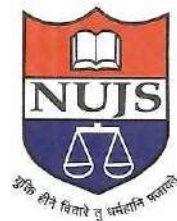
