## CORRIGENDUM

**Subject: GROUP MEDICLAIM INSURANCE POLICY FOR EMPLOYEES AND THEIR FAMILY MEMBERS OF WBNUJS KOLKATA INITIALLY FOR A PERIOD OF ONE YEAR**

In partial modification of Notice Inviting Tender dated 21.08.2023 and subsequent Pre-Bid Meeting dated 25.08.2023 for **Group Mediclaim Insurance Policy for Employees and their Family Members of WBNUJS Kolkata**, the following amendment are made -

- 1) NIT Clause No.8 of General Terms and Conditions, the term shall be read as - **“In the event of dispute, the resolution shall be as per the IRDA Rules and Regulation and the decision shall be final and binding on both the parties”**
- 2) NIT Clause No.17 of General Terms and Conditions of the NIT, the term shall be read as- **“In case of any unsatisfactory services, Penal Interest will be imposed as per IRDA Rules and Regulation”**
- 3) NIT Clause No.19 of General Terms and Conditions of the NIT, the term shall be read as- **“The period of contract will be for a period of one year only”**.
- 4) NIT Clause No.6 of Special Terms and Conditions and Point No.11 of Details of Coverage Required, the additional term may be considered as included - **“Proportionate and PPN Clause to be Waived”**. It is requested to submit the separate quotations as per the following options –
  - i) **Considering waiver of Proportionate and PPN Clause** for Sum Insured of INR 5,00,000/- and INR 10,00,000/-
  - ii) **Without waiver of Proportionate and PPN Clause** for Sum Insured of INR 5,00,000/- and INR 10,00,000/-
- 5) The demographic details list of Employees and their Dependent Members is placed at **Annexure-I**.

The last date of submission of bids will be same i.e. **31.08.2023 (Thursday)** upto **3.00 pm**.
