### Sub: Re-construction Of Anti-Ragging Committee


This is to inform everyone , As per the Guidelines on UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009 (Under Section 26(1) (g) of the University Grants Commission Act, 1956) Section 6.3 which inter-alia states that every institution shall constitute the following bodies; namely, Anti-Ragging Committee to be nominated and Headed by the Head of the Institution, and consisting of representatives of civil and police administration, local media, Non-Government Organisations involved in youth activities, representatives of faculty members, representatives of parents, representatives of students belonging to freshers' category as well as senior students, non-teaching staff; and shall have diverse mix of membership in terms of levels as well as gender.
