The matter arises out of the 83<sup>rd</sup> Meeting of the Executive Council held on 25/06/2022 (Agenda Item No. 7) where the proposal of vertical extension of Academic Building and a New Hostel Building was discussed and the Council directed to defer the matter till the next offline meeting. The Vice Chancellor was requested to submit a detailed note on the Expenditure to be borne from the Core Fund or Development Fund of the University. The Department of Law, Government of West Bengal be communicated regarding utilizing the recurring grant for this purpose.

Accordingly, a detailed note on the Expenditure to be borne from the Corpus Fund of the University has been put up as Annexure 5A. The Law Department, Government of West Bengal has issued a 'No-objection' letter to use University fund for the proposed vertical extension of the Academic Building (Annexure 5B).
