## **Plan of Action - 2023-24**

With regard to internal quality assurance, the Vice Chancellor is pleased to present the following Plan of Action for the University for the Academic Year 2023-2024:

- 1. Faculty Exchange Program:** Following the recommendation from the last IQAC meeting, the modalities for the faculty exchange program, as proposed by Dr. Sarfaraz Ahmed Khan, will be finalized and implemented. The objective is to enhance the academic collaboration and share expertise among national and international institutions.
- 2. Student Wing of IQAC:** Mr. Kavan Patel, President of the Student Juridical Association, is requested to submit names of two students from each batch from First Year to Fifth Year of B.A. LL.B. Programme who will form the new IQAC Students Wing. This initiative aims to integrate student feedback directly into quality assurance processes.
- 3. Civil and Judicial Services Counselling:** Continuing the initiative from the previous academic year, the university will conduct one workshop each semester focusing on careers in civil and judicial services. Dr. Sarfaraz Ahmed Khan and Dr. Shameek Sen will spearhead this effort.
- 4. University Innovation Cell:** The establishment of an IPR Innovation Cell is scheduled for the next academic year. This cell will focus on fostering innovation and managing intellectual property rights within the university context.



**5. Joint Research Projects:** Building on the successful evaluation of interim reports of joint collaborative research projects, the university will continue to promote and support these initiatives. This will include regular monitoring and facilitating the necessary resources for principal investigators.

**6. Recognition and Incentives for Faculty Achievements:** An updated policy for incentives to faculty who receive state, national, or international recognitions/awards will be implemented. This policy aims to motivate and acknowledge outstanding contributions by the faculty.

**7. Faculty Development Programme:** A Faculty Development Programme (FDP) focusing on 'Quantitative Techniques & Statistical Methods' will be held in the last week of June 2024. This program is designed to enhance the research and teaching capabilities of our faculty.

**8. Incubation Centre:** An Incubation Centre will be set up to support student and faculty start-ups, fostering a culture of innovation and entrepreneurship. This centre will collaborate with Leicester University, U.K., to develop skills in Alternative Dispute Resolution (ADR) among participants.

The Vice Chancellor and all members of the IQAC are committed to the successful implementation of these initiatives to enhance the academic environment and operational excellence of the university.
