## Competition Format

Each team shall consist of 3 participants, representing the two negotiators and the Mediator. The Client and the Counsel will compete as a team, whereas the Mediator will compete separately. Two teams will negotiate with each other, representing opposite parties in the presence of two mediators.

General information shall be given to the second week of February so that they can assess the positions and interests of both parties and formulate the best strategy for their client based on the information provided.

The Top 8 teams from the preliminary rounds shall advance to the Quarter-Finals Round, after which teams would advance on a knockout basis.

The Competition invites law students across the globe to showcase their negotiation and mediation skills to get the best deal for their respective clients, while keeping in mind the diverse cultures which the clients may represent. The Competition presents the participants with the opportunity to use their tactics and knowledge by handling complex business transactions. The participants get to brainstorm ideas and solutions that will work best for them to resolve the dispute, which in turn leads to the development of teamwork and critical thinking abilities.
