The Corporation did new assessment and levied a total tax due of Rs. 1,07,15,715/- (Rupees One Crore Seven Lakhs Fifteen Thousand Seven Hundred Fifteen only) vide demand Bill No. BMC/ 2025-2026/115434 dated 04.06.2025.
